Turn By Turn Directions From Louisville

House 1 | The Shafar | Put 246 Wilsonville Road, Fisherville in GPS

Belwood Subdivision

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 2.2 miles on I-265 South. Take Exit 23, turn East onto KY-155 toward Taylorsville Road. Travel 9.3 miles on Taylorsville Road. Take a Right on Goebel Road. Travel .2 miles on Goebel road when it ends and take a left on Wilsonville Road. Travel 1/2 mile on Willsonville Road and Belwood will be on the right. The Shafar is the first home on the left.

House 2 | The Stratton | Put 21 Alexandar Way in GPS

Kingsmill Subdivision

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 2.2 miles on I-265 South. Take Exit 23, turn East onto KY-155 toward Taylorsville Road. Travel 7.9 miles on Taylorsville Road. Take a left onto Kingsmill Drive. In 400 feet, take a right on Jaiden Place. The Stratton is the first home on the left.

House 3 | The Jillian | 2207 White Oak Way, Louisville, KY 40023

Shakes Run Estates

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19B onto I-265 North/Gene Snyder Freeway. Travel 1.3 Miles on I-265 North. Take Exit 27 onto Shelbyville Rd/US-60 toward Eastwood. Travel .3 miles. Turn Right onto Shelbyville Rd. Travel 2.6 miles and take a slight right turn onto Eastwood Cut off Road. Travel .2 miles and turn Right onto Eastwood Fisherville Road. Travel 1.5 miles. Turn left onto Shakes Creek Drive. Travel 1.1 miles. Turn Right onto White Oak Way.

House 4 | The Grand | 205 Gavin Court, Louisville, KY 40245

Persimmon Ridge

Head East on I-64. Travel 1.1 miles on I-64. Take Exit 6 on the right merge onto I-71 N (Toward Cincinnati). Travel 5.6 miles, keep left on I-71 N (toward Cincinnati). Travel 3.7 miles. Take exit 9A onto I-265 South/KY-841 South. Travel 5.9 miles. Take Exit 29 onto Old Henry Road. Turn Left onto Old Henry Road. Travel .7 miles. Turn Right onto Bush Farm Road (turns into Aiken Rd.). Travel 3.3 miles onto Aiken Road. Turn left onto Persimmon Ridge Drive. Travel .9 miles and turn Right onto Oak Tree Lane. Travel .3 miles and turn left onto Persimmon Ridge Drive. Travel .4 miles and turn Left onto Gavin Court. Keep going on Gavin Court through the Cul-de-sac. Until you see the Homearama Sign at the top of the driveway.

House 5 | The Rosemary | 2819 Alder Wood Lane, La Grange, KY 40031

The Commons at Cedar Point

Head East on I-64. Travel 1.1 miles on I-64. Take Exit 6 on the right to merge onto I-71 North (toward Cincinnati) Travel 17.1 Miles. Take Exit 17 onto LaGrange Road (393) . Turn Left onto LaGrange Road (393). Travel 1 mile and turn left onto Cedar Point Road. Travel 1.6 miles and turn right onto Alder Wood Lane.

House 6 | The Rockcastle | 6293 Clore Lane, Crestwood, KY 40014

Brentwood Subdivision

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 14.2 miles. Take Exit 6 on the right to merge onto I-71 N (toward Cincinnati). Travel 14 miles. Take Exit 14 toward Crestwood. Travel .6 miles. Take a Right onto KY-329 E/Hwy 329. Take next Right onto KY-329 E/Hwy 329. Take next right on Sprint Hill Trace (Spring Hill Trace Subdivision). Continue to Brentwood Subdivision. At traffic circle, take the 1st exit to continue on Clore Lane. Follow Clore Lane to House.

House 7 | Avonleigh | 6309 Brentwood Drive, Crestwood, KY 40014

Brentwood Subdivision

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 14.2 miles. Take Exit 6 on the right to merge onto I-71 N (toward Cincinnati). Travel 14 miles. Take Exit 14 toward Crestwood. Travel .6 miles. Take a Right onto KY-329 E/Hwy 329. Take next Right onto KY-329 E/Hwy 329. Take next right on Sprint Hill Trace (Spring Hill Trace Subdivision). Continue to Brentwood Subdivision. Travel .8 miles and turn Right onto Brentwood Drive. Follow to the House.

House 8 | The Timberwalk | 6308 Leyton Court, Crestwood, KY 40014

Brentwood Subdivision

Head East on I-64. Travel 13 Miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 14.2 miles. Take Exit 6 on the right to merge onto I-71 N (toward Cincinnati). Travel 14 miles. Take Exit 14 toward Crestwood. Travel .6 miles. Take a Right onto KY-329 E/Hwy 329. Take next Right onto KY-329 E/Hwy 329. Take next right on Sprint Hill Trace (Spring Hill Trace Subdivision). Continue to Brentwood Subdivision. Travel .8 miles and turn Right onto Brentwood Drive. Travel .5 miles. Turn Right onto Leyton Court. The house is at the end of the court.

House 9 | Gray Dove Manor | 13114 Trump Avenue, Louisville, KY 40299

Dove Point Subdivision

Head East on I-64. Travel 13 miles on I-64. Take Exit 19A onto I-265 South/KY-841 South. Travel 2.2 miles on I-265 South. Take exit 23, turn Right onto KY-155/Taylorsville Road towards Jeffersontown. Travel .7 miles. Take left onto Sweeney Lane. Turn Right onto Dove Point Place (into Community - Dove Point Estates). Travel .3 miles. Turn left onto Trump Avenue. Home will be on left.
